




DryFlow Junior user manual







INSTALLATION INSTRUCTIONS

ALWAYS ENSURE THAT THE INSTALLATION CONFORMS TO THE CURRENT EDITION OF THE IEE WIRING REGULATIONS, BS7671(UK) OR THE APPROPRIATE STANDARDS IN YOUR COUNTRY. ENSURE THAT THE UNIT IS SEPARATELY FÚSED WITH A SUITABLY RATED FUSE AND THAT IT IS CONNECTED TO TO THE SUPPLY WITH A DOUBLE POLE ISOLATING SWITCH HAVING A CONTACT SEPARATION OF AT LEAST 3mm.

CARE SHOULD BE TAKEN THAT SINGLE INSULATED CONDUCTORS CANNOT COME INTO CONTACT WITH THE MOUNTING SURFACE.

THIS HAND DRYER MUST BE FIXED OUT OF REACH OF A PERSON TAKING A BATH OR SHOWER

CAUTION:- THIS APPLIANCE IS NOT INTENDED FOR USE BY PERSONS (INCLUDING CHILDREN) WITH REDUCED PHYSICAL, SENSORY OR MENTAL CAPABILITIES, OR LACK OF EXPERIENCE AND KNOWLEDGE, UNLESS THEY HAVE BEEN GIVEN SUPERVISION OR INSTRUCTION CONCERNING USE OF THE APPLIANCE BY A PERSON RESPONSIBLE FOR THEIR SAFETY.

CHILDREN SHOULD BE SUPERVISED TO ENSURE THAT THEY DO NOT PLAY WITH THE APPLIANCE. THIS APPLIANCE MUST BE FIXED OUT OF REACH OF A PERSON TAKING A BATH OR SHOWER.

MOUNTING INSTRUCTIONS

UNIT MUST BE FIXED TO A SOLID SUPPORTING WALL. SEE OVERLEAF FOR MOUNTING HOLE TEMPLATE. RECOMMENDED FIXING HEIGHTS TO TOP OF UNIT ARE AS FOLLOWS:-

- a) 1.5 METRES ABOVE FLOOR FOR NORMAL USE
- b) 1.3 METRES ABOVE FLOOR WHERE AVERAGE AGE OF USER IS BELOW 16 YEARS THIS HAND DRYER MUST NOT BE MOUNTED ABOVE SHELVES, SINKS OR RADIATORS TO ENSURE EASE OF INSTALLATION AND SUBSEQUENT MAINTENANCE, THE HORIZONTAL DISTANCE TO ANY ADJACENT WALL SHOULD NOT BE LESS THAT 0.2 METRES

AFTER INSTALLATION OR SERVICING, UNITS MUST BE CHECKED, AND ONLY LEFT WHEN ELECTRICALLY AND MECHANICALLY SAFE.

When ordering replacement modules always quote SERIAL NO., MODEL/SERIES, ELECTRICAL SUPPLY VOLTAGE AND FREQUENCY.

SERVICING THE HAND DRYER

THE MINIMUM SERVICE PERIOD FOR THE DRYER SHOULD BE EVERY 3 MONTHS OR MORE FREQUENT INTERVALS AS EXPERIENCE DICTATES

ISOLATE THE UNIT FROM THE ELECTRICITY SUPPLY BEFORE SERVICING. REMOVE DUST, FLUFF AND ANY OTHER BUILD UP OF FOREIGN MATTER FROM INLET AND OUTLET GRILLE AREAS



This marking indicates that this product should not be disposed with other household wastes throughout the EU. The hand dryer is Guaranteed for two years from the date of purchase against faulty materials or workmanship.


In the event of any part being found to be defective, the hand dryer will be repaired, or at the Manufacturers option replaced, without charge, provided that the hand dryer:

- c) has not been subjected to mis-use, neglect or damage.
- d) has been properly serviced in accordance with the instructions given with each unit.
- e) has not been modified or repaired by any person not authorised by the Manufacturer.

This quarantee excludes labour after an initial 12 month period.
